



**Contract**  
in the subject matter of execution of the project called  
**„ Project of building an open access recreation zone for children in  
Krasnystaw”**

The contract parties:

1. The Commune of Krasnystaw, seat in Krasnystaw (22-300), Plac 3-go Maja 29 as the Leading Partner (The Applicant) represented by:  
Mayor Andrzej Jakubiec.
2. The municipality of Gjøvik, Serviceboks, 2810 Gjøvik, Norway, as the Norwegian Partner – represented by:  
Mayor Kåre Haugen .

The Commune of Krasnystaw and Gjøvik have decided, attempting to establish business relationships by means of sharing experience as well as cross regional co-operation, to conclude the present contract.

In order to effectively execute the project called „ Project of building an open access recreation zone for children in Krasnystaw” which is submitted to the European Economic Area Financial Mechanisms as well as to Norwegian Financial Mechanisms, the parties of the contract commit themselves to:

§ 1

1. The Leading Partner commits to:
  - prepare the aforementioned project and to prepare the application for granting of subsidies from the EEA Financial Mechanisms funds;
  - co-ordinate project activities together with the Norwegian partner;
  - carry out reporting and accounting of the project;
  - promote the co-operation during the course of realisation of the project and its results;
2. The Applicant bears full responsibility for the project.

§ 2

The Norwegian Partner commits to:

- share experiences in the fields of: regional development, provision of public services, environmental protection, cultural heritage protection, human resources development, provision of health care;

- share experiences in managing sustainable development policies (waste management, biological diversity) and to develop the Local Agenda 21;
- share experiences in managing local public business entities operative in the field of media management (water supply systems, waste management, energy);
- share experiences in the field of stimulation of public dialogue;
- share experiences in the field of application of environmentally friendly technologies;
- promote the co-operation during the course of realisation of the project and its results;
- participate in the performance of the project by means of counselling the Applicant on matters connected with the project execution.

§ 3

1. This contract is concluded for an infinite period of time.
2. The contract enters into force as of the day of its signing.
3. The contract is concluded in two identical copies, each of them in both the Polish and the English languages, while both of these versions are to be treated as equally binding.
